





**Subject:- Report regarding pot holes pertaining to North DMC.**

In reference to the telephonic discussion with CE-V the desired information, on the mentioned subject, as required for Court case, is submitted as under:-

S.No.	Name of Road	Reach/Location	Action taken Report
1	Rani Jhansi Road	Azad Market Chowk	CC road has been constructed by Project Division at Azad Market Chowk on Rani Jhansi road and there is no pot holes at Azad Market Chowk. Beyond Azad market chowk towards Pul methai, road pertains to PWD.
2	Road No.40	Near Y point red light	Patch repair on road no. 40 upto Y point red light has been carried out by North DMC. Beyond that, road pertains to PWD.
3	Road No.40	Near under pass Kishan Ganj.	Katcha patch repair has been done on Road no.40 under pass Kishan Ganj. However Dense carpeting cannot be carried out as the Railways have to demolish this bridge for construction of push box. Tenders have been invited by Railways for constructions of push box in this regard.
